POLL RESULTS OF ANNUAL GENERAL MEETING

The Board announces that all resolutions have been duly passed by the Shareholders at the AGM held on 27 May 2026.

Reference is made to the circular of SoftMedx Healthcare Limited (the “Company”) dated 4 May 2026 containing the Notice of Annual General Meeting. Capitalised terms used in this announcement shall have the same meaning as those defined in the circular.

POLL RESULTS OF THE AGM

As at the date of the AGM, the total number of issued Shares was 107,116,933 Shares, which was also the total number of Shares entitling the holders to attend and vote on the resolutions proposed at the AGM. There was no Shareholder who was required to abstain from voting on the resolutions and there was no Shareholder who was entitled to attend the AGM but was required to abstain from voting in favour of the resolutions in accordance with Rule 13.40 of the Listing Rules. There was no Shareholder who had stated his/her/its intention in the circular to vote against or abstain from voting on the resolutions. All Directors attended the AGM.

The Company’s share registrar in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer for the purpose of vote-taking at the AGM. All votes cast at the AGM were duly counted and included in the voting results. The poll results of the resolutions are as follows:
